### **Election to fill a vacancy on the Finance Committee, in accordance with section 9, paragraph 5, of the annex to the Agreement relating to the Implementation of Part XI of the United Nations Convention on the Law of the Sea of 10 December 1982**

#### **Note by the Secretary-General**

1. The Assembly of the International Seabed Authority is invited to note that Sun Zhi (China) resigned from the Finance Committee with effect from 3 August 2020. He had been elected by the Assembly at its twenty-second session as a member of the Committee for a term of five years commencing on 1 January 2017 and ending on 31 December 2021 (see [ISBA/22/A/14](#)).
2. Section 9, paragraph 5, of the annex to the Agreement relating to the Implementation of Part XI of the United Nations Convention on the Law of the Sea of 10 December 1982 provides that, in the event of the death, incapacity or resignation of a member of the Committee prior to the expiration of the term of office, the Assembly shall elect for the remainder of the term a member from the same geographical region or group of States.
3. By a note verbale dated 7 August 2020, the Permanent Mission of China to the Authority informed the secretariat of the Authority of the nomination of Fan Kejun as a candidate to fill the seat on the Committee left vacant by Mr. Sun for the remainder of his term ending on 31 December 2021. The curriculum vitae of Mr. Fan is contained in the annex to the present note.
