## 5. Aims and Purposes of the Organization

The International Association of Drilling Contractors is a non-profit, international organization established to:

- To promote improvements in efficiency, quality, health, safety, environmental and technical standards through its conferences, periodicals and publications;
- To educate and train industry personnel and familiarize them with advanced methods and equipment;
- To seek to improve the efficiency of the international oil well drilling industry; and
- Promote cooperation and understanding with other industry organizations and governmental bodies.

## 6. History

IADC was first chartered in 1940 as the American Association of Oilwell Drilling Contractors (AAODC). In 1944, IADC's magazine, *Drilling Contractor*, was first published and its Safety Committee was organized as a standing committee. IADC's offshore interests were solidified in 1948 when the first well was drilled out of sight of land in the Gulf of Mexico. In the early 1950's the AAODC began dealing with the regulatory and technical issues associated with offshore drilling from what were to become known as mobile offshore drilling units.

Due, in large part, to the interest of its members in the worldwide offshore drilling market, in 1972 the AAODC became the International Association of Drilling Contractors, and in 1973, the IADC's North Sea Chapter was formed.

In 1975, the IADC was granted consultative status by the International Maritime Organization and began working toward the development of the "Code for the Construction and Equipment of Mobile Offshore Drilling Units, 1979." IADC remains an active participant in the IMO's Maritime Safety, Legal and Marine Environmental Protection Committees and their Sub-Committees.

## 7. Recent and Planned Activities

In its efforts to promote efficiency, quality, health, safety and environmental protection, IADC sponsors or co-sponsors numerous conferences. IADC is a sponsoring organization for the Offshore Technology Conference, held annually in Houston in May.

In November 1997, IADC participated in the International Experts Meeting for Environmental Practices in Offshore Oil and Gas Activities co-sponsored by the Governments of Brazil and The Netherlands under the auspices of the United Nations Commission on Sustainable Development.

8. **Descriptive statement of the extent to which the purposes of the organization relate to those of the ISA including, in particular, what contribution can be made to the program of the ISA**

Offshore wells are being routinely drilled in water depths in excess of 2,000 meters. The locations of offshore wells are approaching the limits of the continental shelf. Accordingly, it is IADC's view that matters relating to the design, construction and operation of offshore wells will become, in the near future, a matter under consideration by the International Seabed Authority.

The IADC is in the position to provide highly specialized expertise in:

- Commercial and functional matters relating to offshore oil and gas well drilling;
- Well control; and
- Design, construction and operation of mobile offshore drilling units (MODUs).

9. **Structure**

IADC is governed by an Executive Committee of 12 officers elected by its Directors. IADC has three operational divisions: Land, Offshore and Drilling Services which may form committees or workgroups in furtherance of the organization's objectives. For example, a sub-committee has been formed under the auspices of the Offshore Division to address issues arising at the International Maritime Organization.

## 10. Membership

IADC welcomes the membership of all companies involved in the worldwide upstream petroleum industry that share a commitment to improving safety, advancing drilling technology, striving for reasonable regulation and legislation, and enhancing the training and education of technical and management personnel.

IADC offers three types of membership:

- Contractor, reserved for contract-drilling or well-servicing firms, whether on land or offshore;
- Producer, open to all energy-producing companies;
- Associate, available to manufacturers, suppliers, consultants, educators, oilfield-service firms and others with a professional or commercial interest in the upstream energy industry.

IADC is the only worldwide organization representing virtually the entire global drilling industry. In 1998, IADC's membership comprised 288 Contractor members, 74 Producer members and 552 Associates. IADC Contractor members operate nearly 3,000 drilling rigs of all types. IADC's Offshore Division includes all of the drilling contractors offering mobile offshore drilling units on a competitive basis worldwide. According to IADC records, members of IADC's Offshore Division have drilled oil and gas wells on the continental shelf or inland waters of over 80 nations.

**14. Finance**

IADC's operating budget for 1999 exceeds \$US 3,000,000. This amount does not include Chapter operating expenses or technical studies funded by subscription by IADC Committees.

**5. Publications**

**6. Remarks**

Two incidents led to IADC's interest in seeking consultative status with the ISA:

- The realization, during the development of the IADC Deepwater Well Control Guidelines, that offshore drilling operations under the jurisdiction of the ISA were reasonably foreseeable; and
- The Comité Maritime International's (CMI's) submission to the IMO's Legal Committee of a paper (LEG 78/10) suggesting that consideration be given to developing a comprehensive international instrument governing offshore activities. In this paper, the CMI identified ISA as an organization to be included in any such negotiations.
