REQUESTS FOR EXTENSION OF PROVISIONAL MEMBERSHIP

1. The Agreement relating to the Implementation of Part XI of the United Nations Convention on the Law of the Sea of 10 December 1982 (hereafter referred to as "the Agreement") entered into force on 28 July 1996. According to the Agreement, the membership in the Authority of those States and entities which have been applying it provisionally in accordance with its article 7 terminates upon entry into force of the Agreement, unless it is extended as provided for in the Agreement.

2. Under paragraph 12 (a) of section 1 of the annex to the Agreement, the Council may, upon the request of the State or entity concerned, extend membership of the Authority on a provisional basis for a further period or periods not exceeding two years provided that the Council is satisfied that the State or entity concerned has been making efforts in good faith to become a party to the Convention and the Agreement.

3. At the resumed second session of the Authority, held at Kingston from 5 to 16 August 1996, the Assembly, on the recommendation of the President, decided that, in order to facilitate participation in the meetings of the Authority by those States which had communicated in various forms their intention to continue implementation of the Agreement on a provisional basis but which had not, following the entry into force of the Agreement, notified the depositary in the required form of such intention, it was prepared to accept that such States should continue to participate in the meetings of the Authority for that session on a provisional basis (ISBA/A/L.10, para. 3).

4. In addition, at the same session, the Council decided that those States or entities which submit requests for an extension of membership on a provisional basis beyond 16 November 1996 prior to the next session of the Council shall be deemed to be members of the Authority on a provisional basis until the end of the next session of the Council, at which time the Council will deliberate on such request (ISBA/C/3, para. 3). Such requests should be submitted to the

Secretary-General of the Authority. At the request of the Council, the Secretary-General also circulated, on 27 August 1996, to those States and entities which, prior to its entry into force, had been applying the Agreement provisionally, a letter bringing to their attention the requirements contained in paragraph 12 (a) of section 1 of the annex to the Agreement concerning the continuation of participation on a provisional basis after 16 November 1996.

5. As of 25 February 1997, 14 States and one entity had submitted requests to extend membership on a provisional basis beyond 16 November 1996. They are: Belarus, Belgium, Chile, European Community, Gabon, Lao People's Democratic Republic, Mozambique, Poland, Qatar, Russian Federation, Solomon Islands, Switzerland, Ukraine, United Arab Emirates and United Kingdom of Great Britain and Northern Ireland. The text of the requests appears in the annex to the present document.

Solomon Islands requests that the Council of the Authority extend Solomon Islands' provisional membership of the Authority for a period of two years, from 16 November 1996. Solomon Islands has applied the Agreement provisionally as of February 1995 pending its entry into force for Solomon Islands. The Government of Solomon Islands remains committed to the ratification of the 1982 Convention but unfortunately, the necessary internal procedures to enable Solomon Islands to ratify have not yet been completed. Solomon Islands wishes to inform the Council and the Authority that it will continue to make good-faith efforts to become a party to the Convention and the Agreement.

On 16 November 1996, Switzerland's status as a member, on a provisional basis, of the International Seabed Authority will come to an end, unless it requests an extension.

This extension is justified, in the view of the Swiss authorities, by the fact that Switzerland intends to ratify the Convention soon and, to that end, will send a message to Parliament, at the beginning of 1997, with a view to approval of the Convention. Once the message has been sent, the procedure for parliamentary approval and ratification will take at least one year.
