**Consideration, with a view to approval, of applications for extension of a contract for exploration, if any**

### **Draft decision of the Council relating to an application for extension of the contract for exploration for polymetallic nodules between Deep Ocean Resources Development Co. Ltd. and the International Seabed Authority**

*The Council of the International Seabed Authority,*

*Acting upon the recommendation of the Legal and Technical Commission,<sup>1</sup>*

*Recalling that, on 20 June 2001, Deep Ocean Resources Development Co. Ltd. entered into a 15-year contract for exploration for polymetallic nodules with the International Seabed Authority,*

*Recalling also that the contract was extended for a period of five years to 19 June 2021,<sup>2</sup> and a further five years to 19 June 2026<sup>3</sup>.*

*Noting that, on 9 December 2025, the Secretary-General of the Authority received an application for an additional five-year extension of that contract.*

*Recalling section 1, paragraph 9, of the annex to the Agreement relating to the Implementation of Part XI of the United Nations Convention on the Law of the Sea of 10 December 1982,<sup>4</sup>*

*Recalling also the decision of the Council of the Authority relating to the procedures and criteria for the extension of an approved plan of work for exploration pursuant to section 1, paragraph 9, of the annex to the Agreement,<sup>5</sup>*

*Considering* the report and recommendations of the Legal and Technical Commission relating to the application by Deep Ocean Resources Development Co. Ltd. for extension of the contract,<sup>6</sup>

1. *Decides* to approve the application for extension of the contract;
  2. *Requests* the Secretary-General to take the steps necessary to execute the extension of the contract, with effect from 20 June 2026, by signature of an agreement in the form set out in appendix II to the annex to the decision of the Council of the International Seabed Authority mentioned above,<sup>7</sup>
  3. *Also requests* the Secretary-General to report to the Council at its next session on the status of the extension agreement.
