**Consideration, with a view to adoption, of the draft
regulations on exploitation of mineral resources in the Area**

Decision of the Council of the International Seabed Authority on the approach to the continuation of the elaboration of rules, regulations and procedures relating to exploitation and resolution of the remaining key outstanding issues

The Council of the International Seabed Authority,

Reiterating that the commercial exploitation of mineral resources in the Area should not be carried out in the absence of rules, regulations and procedures relating to exploitation,

Recognizing the progress made towards resolving the remaining key outstanding issues in the elaboration of rules, regulations and procedures relating to exploitation,

Recalling its decision [ISBA/30/C/18](#), the draft indicative list of outstanding issues¹ and the updated draft indicative list of outstanding issues,²

Emphasizing the importance of a predictable programme of work and intersessional work with active participation from all delegations,

Taking note of its decision [ISBA/31/C/34](#) relating to the reports of the Chair of the Legal and Technical Commission,³

1. *Requests* the secretariat to draft a road map, for consideration by the Council at the first part of its thirty-second session, setting out milestones for the timely adoption of the rules, regulations and procedures relating to exploitation and an updated indicative list of key outstanding issues that require further thematic discussion by the Council, having regard to progress made and the need for prioritization;

2. *Also requests* the secretariat to share the draft road map referred to in paragraph 1 of the present decision by 31 October 2026, organize webinars to present

it, provide for written comments on it to be submitted to the secretariat by 31 December 2026 and share an updated draft at least one month in advance of the first part of the thirty-second session;

3. *Further requests* the secretariat to provide an advance negotiating text, which harmonizes and streamlines the further revised consolidated text⁴ and takes into account discussions and outcomes achieved during the thirty-first session, as well as subsequent intersessional input, and to upload it to the website of the International Seabed Authority at least six weeks in advance of the first part of the thirty-second session;

4. *Calls on* member States, during the intersessional period in advance of the thirty-second session, to participate in an informal working group to discuss updates to working methods so as to enable the Council to focus on the key issues that require further thematic discussion and seek to avoid a line-by-line reading of the draft exploitation regulations, and requests that the facilitator of the informal working group report back to the Council on the discussions;

5. *Also calls on* member States to actively participate in intersessional work, and requests those informal working groups and Friends of the President groups for which facilitators have already been identified to continue their work on the relevant regulations and to identify, where necessary, key outstanding issues requiring further thematic discussion by the Council at the thirty-second session;

6. *Requests* the secretariat to provide an indicative programme of work for the first part of the thirty-second session focusing the Council's consideration on the key outstanding issues that require further thematic discussion, and to circulate the indicative programme of work at least one month in advance of the first part of that session.
