Status of the implementation of training programmes under plans of work for exploration and the allocation of training opportunities

Selection of candidates for training programmes under plans of work for exploration

Recommendations by the Legal and Technical Commission

1. During the period following the first part of the thirty-first session, held in March 2026, a total of thirty-nine training opportunities were offered by eleven contractors pursuant to their contracts for exploration with the International Seabed Authority (see annex I). These placements comprised:

- (a) One internship placement offered by the Institut français de recherche pour l'exploitation de la mer (Ifremer) pursuant to its contract for polymetallic sulphides;
- (b) Two at-sea on-board training placements offered by Tonga Offshore Mining Ltd. (TOML) pursuant to its contract for polymetallic nodules;
- (c) One internship placement offered by Global Sea Mineral Resources NV (GSR) pursuant to its contract for polymetallic nodules.
- (d) Five fellowship training placements offered by Beijing Pioneer Hi-tech. Development Corporation Ltd. (BPC) pursuant to its contract for polymetallic nodules;
- (e) Two engineering training placements offered by China Ocean Mineral Resources R&D Association (COMRA) pursuant to its contract for cobalt-rich ferromanganese crusts;
- (f) Eight practical on-board training placements offered by the Government of the Republic of Poland (Poland) pursuant to its contract for polymetallic sulphides;
- (g) Six theoretical training placements offered by the Ministry of Natural Resources and Environment of the Government of the Russian Federation (MNRE) pursuant to its contract for polymetallic sulphides;
- (h) Four theoretical training placements offered by JSC Yuzhmorgeologiya pursuant to its contract for polymetallic nodules

(i) Two on-land training placements offered by Deep Ocean Resources Development Co. Ltd. (DORD) pursuant to its contract for polymetallic nodules;

(j) Four engineering training placements offered by China Minmetals Corporation (CMC) pursuant to its contract for polymetallic nodules; and

(k) Four at-sea on-board training placements offered by Federal Institute for Geosciences and Natural Resources (BGR) pursuant to its contract for polymetallic sulphides.

2. To accommodate scheduling demands for the training programmes, the Legal and Technical Commission, prior to the commencement of the second part of the thirty-first session and in accordance with the recommendations of the training subgroup, selected 29 candidates for the training programmes offered by Ifremer, TOML, GSR, BPC, COMRA, Poland, MNRE and JSC Yuzhmorgeologiya (see annexes I and II).

3. During the second part of the thirty-first session, the selection of candidates was conducted by the Commission for the remaining six training opportunities offered by DORD and CMC (see annexes I and III). The selection of candidates for the training programme offered by BGR will be conducted in the upcoming intersessional period.

4. Additionally, on 7 July 2026, a request was received from Ocean Mineral Singapore Pte Ltd (OMS) to increase the number of reserve candidates to accommodate withdrawals of candidates previously selected by the Commission (see ISBA/31/LTC/5). There is one first-ranked placement vacant and in the interest of time, OMS is seeking the support of the Commission to select more candidates to avoid having to readvertise the programme given that the aim is to implement the opportunity in September 2026. Given the timeframe, the Commission recommended, from the initial pool of candidates, the subsequent 10 candidates with the highest ranking as the additional reserves (see Annex III).

5. Candidates were selected on the basis of the criteria provided by contractors. Due consideration was given to gender balance and equitable geographical distribution, with particular attention given to the interests and needs of the least developed countries (LDCs), landlocked developing countries (LLDCs) and small island developing States (SIDS), as requested by the Council in a decision adopted at the twentieth session (see [ISBA/20/C/31](#), para. 6) and reiterated in the decision of the Assembly relating to the implementation of a programmatic approach to capacity development ([ISBA/26/A/18](#)), adopted at the twenty-sixth session, and formalized through the adoption in 2022 of the capacity development strategy (see [ISBA/27/A/11](#)).

6. A breakdown of the selection figures shows that since March 2026, regionally, of the 35 selected first-ranked candidates, 14 (40 per cent) were from the Group of African States, 15 (43 per cent) from the Group of Asia-Pacific States, and six (17 per cent) from the Group of Latin American and Caribbean States. A further breakdown shows that 43 per cent were from the special needs grouping namely, 12 (34 per cent) were from LDCs, three (9 per cent) from SIDS and LDCs/SIDS grouping respectively (see annexes II and III).

7. Contractors continue to contribute positively to the implementation of the Women in Deep-Sea Research project (WIDSR).¹ For the current reporting period, all the contractors who offered training programmes have pledged 50 per cent of their training

opportunities to suitably qualified women, where possible (see annex I). Among the selected first-ranked candidates, 18 (51 per cent) were women (see annexes II and III).
